**RESOLUTION TO DETERMINE ESTIMATE OF FUNDS NEEDED FOR 2018/2019 FISCAL YEAR**

**WHEREAS**, the Roselle Public Library District ("Library District") must file on or before December 31, 2018, its levy ordinance for the 2018/2019 fiscal year;

**WHEREAS**, pursuant to the "Truth in Taxation Act" (35 ILCS 200/18-55, *et seq.*), the Library District must determine not less than twenty (20) days prior to adoption of its Levy Ordinance the amounts of money estimated to be necessary to be raised by taxation for the 2018/2019 fiscal year upon the taxable property of the Library District;

**NOW, THEREFORE, BE IT RESOLVED** and determined by the Board of Trustees of the Library District that the amount of money estimated to be necessary to be raised by taxation, exclusive of bond retirement costs, for the 2018/2019 fiscal year upon the taxable property in the Library District, is \$2,154,950.60.

**BE IT FURTHER RESOLVED** that a public hearing pursuant to the Truth in Taxation Act shall be held on the 14<sup>th</sup> day of November, 2018 at 7:00 p.m., at the Roselle Public Library, 40 South Park Street, Roselle, Illinois.

**BE IT FURTHER RESOLVED** that notice of said public hearing in compliance with the Truth in Taxation Act shall be given in the *Daily Herald*, an English language newspaper of general circulation in the Library District, not more than fourteen (14) days nor less than seven (7) days prior to the date of the public hearing, and the notice of said public hearing shall also be posted on the website of the Library District not more than fourteen (14) days nor less than seven (7) days prior to the date of the public hearing.
